A RESOLUTION TO ACCEPT, APPROPRIATE AND TRANSFER FUNDS FY 2010 CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT PROGRAM

WHEREAS, the City of Lancaster is in receipt of its FY 2010 Community Development Block Grant (CDBG) Grant Agreement and funding approval in the amount of \$610,998 for the program year commencing September 1, 2010; and

WHEREAS, program income from the repayment of housing rehabilitation loans and/or acquisition assistance loans in the amount of \$5,000 is available to be transferred and appropriated to the FY 2010 Private Housing Rehabilitation Account and/or FY 2010 Acquisition Assistance Account.

WHEREAS, it is necessary that said CDBG funds be accepted, appropriated, and transferred in accordance with the approved and authorized FY 2010 program; now, therefore

BE IT RESOLVED by the Council of the City of Lancaster, State of Ohio

SECTION 1. That the City of Lancaster's FY 2010 Community Development Block Grant in the amount of Six Hundred Ten Thousand Nine Hundred Ninety-Eight Dollars (\$610,998) is hereby accepted.

SECTION 2. That the above grant (\$610,998) and program income (\$5,000) are hereby appropriated as follows, in accordance with the FY 2010 CDBG Annual Action Plan as authorized by Council per Permanent Resolution No. 67-10, dated June 28, 2010:
