PERMANENT ORDINANCE NO. 77-05

AN ORDINANCE TO AMEND SECTION 1341.01(A) & (B) LANCASTER CODIFIED ORDINANCE REQUIRING REGISTRATION OF ELECTRICAL, MECHANICAL, PLUMBING, ROOFING/SIDING, MASONRY, HYDRONICS, GENERAL CONTRACTORS, AND WATER AND SEWER LINE INSTALLERS PERFORMING SERVICES IN THE CITY, TO REPEAL EXISTING LANCASTER CODIFIED ORDINANCE 1341.01 (A) & (B), AND TO DECLARE AN EMERGENCY

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Lancaster, Fairfield County, Ohio, that:

SECTION 1. That Section 1304.01(a) and (b) be amended to read as follows:

**1304.01 Contractor Registration Categories and Definitions**

**A. GENERAL**- means those persons, business or companies that directly engage in building construction and hire subcontractors to provide construction services for specific skilled trades. As of 2005 a state license is not required to register as a general contractor. The general contractor may perform limited work, as the Building Department determines, on residential projects that are listed under the "skilled trades" category. All work that involves more than limited work must be completed by persons, businesses or companies registered under the applicable skilled trade category.

**B. HOME IMPROVEMENT or SPECIALTY**- means those persons, businesses or companies that directly engage in specific construction activities, alterations or renovations. As of 2005 a state license is not required to register under this category. Home improvement or specialty contractors are permitted to perform limited work, as determined by the Building Department, on residential projects that are listed under the "skilled trades" category. All work that involves more than limited work must be completed by persons, businesses or companies registered under the applicable skilled trade category.

**1. Home Improvement-Specialty Trades:**

(Registration under more than one specialty permitted if bond provided reflects each specialty)

**a. Drywall/Plaster**- means those persons, businesses or companies that provide drywall (gypsum board) or cement plaster installation, repair or replacement in or on a building structure.

**b. Deck**- means those persons, businesses or companies that provide services to install, repair or replace an exterior floor system supported on at least two opposing sides by adjoining structure and/or posts, piers, or other independent supports.

**c. Demolition/Hauling**- means those persons, businesses or companies that provide services to demolish structures and remove construction materials from a specific location.

d. **Excavator/Tapper**- means those persons, businesses or companies that provide services to remove, replace, compact or grade earth for construction projects and to install, tap into, repair or replace sewer, water, gas or other utilities lines or cables.

e. **Framing**- means those persons, businesses or companies that provide services to install, repair or replace structural components, beams, framework, or deck work in a building structure.

f. **Gutter/Spouting**- means those persons, businesses or companies that provide installation, repair or replacement on any system of water collection or diversion of water from a roof system through drain lines on or about a building structure.

g. **Landscaping**- means those persons, businesses or companies that provide the installation of lawns, tree, shrubbery or bushes at or about building construction sites.

h. **Masonry/Cement/Asphalt**- means those persons, businesses or companies that provide services for installation of block, bricks, stone, cement or asphalt at or on a building structure or construction site.

i. **Roofing**- means those persons, businesses or companies that provide services to install replace or repair a system designed to provide weather protection and resistance to design loads consisting of roof decking, vapor retarder, substrate and roof covering.

j. **Siding**- means those persons, businesses or companies that provide services to install, replace or repair a covering material on the exterior of building structures as to protect the structure against weather elements.

k. **Sign & Graphics**- means those persons, businesses or companies that provide services to install, repair, replace or modify publicly displayed boards that contain information, advertising or symbols including any form of visual artistic representation.

l. **Swimming Pool**- means those persons, businesses or companies that provide services to dig and install, repair or replace indoor or outdoor tank(s) of water and pumping and filtering equipment used for human swimming purposes.

m. **Waterproofing**- means those persons, businesses or companies that provide services to install, apply or remove materials applied to building foundations, walls, and floors to prevent the penetration of water into the interior of a building structure.

n. **Windows**- means those persons, business or companies that provide services to install, repair or replace framed glass structures installed on the exterior of building structures.

## 2. **Skilled Trades**

State Contractors license required to register for skilled trades on commercial projects

a. **ELECTRICIAN**- means those persons, businesses or companies that provide services to install, repair or replace electrical apparatus or appurtenances within or about a building structure or specific location.

b. **FIRE/SECURITY DETECTION & SUPPRESSION**- means those persons, businesses or companies that provide services to install, repair, test and replace fire or security detection equipment, reporting devices, fire sprinklers and piping, stand pipes, fire suppression equipment and suppression hoods.

c. **HYDRONICS**- means those persons, businesses or companies that provide services to install, repair or replace fluid, steam or gas pressure piping systems within a structure.

d. **HVAC**- means those persons, businesses or companies that provide services to install, repair or replace heating, ventilating, and air-conditioning systems within a building.

e. **PLUMBER**- means those persons, businesses or companies that provide services to install, repair or replace pipes and fixtures used to transport water and sewage within or about a building structure or property.

f. **REFRIGERATION**- means those persons, businesses or companies that provide services to install, repair and replace systems that vaporize and liquefy a fluid used for refrigerate storage systems and other components attached.

SECTION 2. That existing Section 1341.01(A) and (B) is hereby repealed.

SECTION 3. That a real and present emergency exist and that this ordinance shall take effect and be in force immediately upon passage for the preservation of public safety and welfare by ensuring that contractors are insured and licensed protecting against theft, exploitation, and fraud.

**Contractor Registration**  
Revised 1005

The City of Lancaster requires contractor registration per City Ordinances and through powers granted under the Ohio Revised Code. This includes any individual or company acting as a general, home improvement, specialty trade or skilled trades contractor including any construction activities such as electrical, plumbing, hydronics, heating & cooling, structural (includes all building construction, roofing, siding, gutters, water proofing, cement and drywall trades), masonry, fire protection, fire suppression, water and sewer line tapping or excavation within the City of Lancaster.

No person shall act as or claim to be a construction contractor of any type, or perform any construction work on any commercial or residential construction unless first registered with the Certified Building Department.

No person shall act as or claim to be a heating, ventilating, air conditioning contractor, refrigeration contractor, plumbing contractor, electrical contractor, or hydronics contractor, unless that person holds or has been assigned a license issued pursuant to Ohio Revised Code Chapter 4740, for the type of contractor that person is acting as or claiming to be. This means all skilled trade contractors must show proof of a license issued by the State of Ohio Contractors Licensing Board to register with the City of Lancaster on commercial construction projects located within the City. ORC 4740.13

The following items must be submitted to register:

- Completed contractor registration application. Commercial contractors must attach a copy of State license(s) for each trade checked on the application. ORC 715.27
- Proof of liability insurance with a minimum coverage of \$300,000. Copy of certificate of coverage from insurance company must be attached.
- A \$15,000 Surety Bond payable to the City of Lancaster. Use the attached bond form.
- A copy of current Workers Compensation Certificate for businesses that have more than one employee.
- Registration Fee of \$100.00 applies for each major category that is applied for on the application. Categories are general, home improvement/specialty or each skilled trade. Payment must be cash or check payable to "Lancaster City Treasurer". The registration fee is for a 12 month period.
- A completed "Tax Business Questionnaire" form.

All completed forms, licenses and documentation must be returned together with the registration fee to be considered. Fees cannot be accepted without all documentation and forms. **PLUMBER**- means those persons, businesses or companies that provide services to install, repair or replace pipes and fixtures used to transport water and sewage within or about a building structure or property.

**REFRIGERATION**- means those persons, businesses or companies that provide services to install, repair and replace systems that vaporize and liquefy a fluid used for refrigerate storage systems and other components attached.

Ohio Revised Code and Lancaster City Ordinance permit the Building Department to determine the contractor registration process. After the application is filed and fee(s) paid the contractor is instantly registered. The application is then entered into our data base where a registration number unique to the contractor will be issued. The registration number process usually takes two business days. The registered contractor shall be listed on our Internet Web site with current business name, address and telephone number under the category(s) for which the contractor has registered.

Consumers, upon request, will be given a list of registered contractors as a matter of public record, but this does not constitute an endorsement or advertising of any contractor's products or services by the City of Lancaster.

Contractors who fall into the listed categories and are performing work in the City of Lancaster must register. Registration must be renewed every 12 months to remain current. The penalty for failure to register is a first degree misdemeanor. Contractors engaging in commercial work without a State License will be forwarded to the Ohio Construction Industry Licensing Board for investigation and prosecution.

**Individual, Organization and Business Registration Exemptions**

**The following individuals, organizations and businesses are exempt from registering as a contractor with the Building Department:**

- The owner occupant of a single family residence performing any activities that do or do not require permits. Homeowner Permit Affidavit form must be completed and submitted prior to the issuance of any permits.
- The owner of any one, two or three family home that is used as a rental or lease property, when the owner performs work activities that normally does not require a permit. If a permit is required, the owner shall provide a \$15,000 Surety Bond to the Building Department to assure permitted projects are completed. The owners name will not appear on the City Internet site. Owners of rental or lease properties shall, upon the request of any Building Official, produce evidence of ownership of any building when activities that normally do not require a permit are observed or reported to our office. Any contractors hired by the owner shall be registered. Owners of four or greater family homes are regulated by the OBC and are considered a commercial building, therefore the owner is required to register under the appropriate trade categories.
- Any charitable or non-profit organization of a single family home that is under construction who utilizes volunteers to perform construction activities normally performed by contractors. Such organizations shall submit proof of liability insurance to the Building Department on an annual basis. Any contractors hired by the organization shall be registered.
- Any business that utilizes personnel directly employed by the company to perform activities on company owned property that may or may not require permits. A company official must complete a Registration Exemption Affidavit form. Any contractors hired by the company shall be registered.

**NOTE: Exception from Contractor Registration does not mean exception from providing plan submittals and attaining approvals, building permits and required inspections to comply with all building codes and ordinances in effect.**
