PERMANENT RESOLUTION NO. 189-12

A RESOLUTION TO AMEND THE 2012 APPROPRIATION AND REVENUE BUDGETS AND TO AMEND THE CERTIFICATE OF APPROPRIATIONS AND OTHER SOURCES WITH THE COUNTY AUDITOR

WHEREAS, this resolution is to bring the City revenue and appropriation budgets in line so that they will not be over appropriated (over budgeted) as of December 31, 2012. All Fund budgets cannot exceed actual cash carryover plus actual cash received during 2012.
