PERMANENT RESOLUTION NO. 109-11

A RESOLUTION TO AUTHORIZE THE MAYOR TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY TO FACILITATE THE TRANSFER OF 310 NORTH COLUMBUS STREET IN THE CITY OF LANCASTER TO THE LANCASTER PORT AUTHORITY

WHEREAS, the City no longer needs this property and as the City does not desire to market and sell the lot; and

WHEREAS, the Lancaster Port Authority has more flexibility in its marketing and sales; and

WHEREAS, the City desires the Port Authority to retain a 5% seller's fee for Port Authority Projects with 95% of sale price being returned to the General Fund;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the City hereby transfers in fee simple the property located at 310 North Columbus Street (as described in Exhibit A) to the Lancaster Port Authority.

SECTION 2. That the City no longer needs the property and the City does not desire to market and sell commercial/industrial property since the City created the Lancaster Port Authority to facilitate said development.

SECTION 3. The Mayor is hereby authorized to execute any and all documents necessary to facilitate the transfer of the property.

SECTION 4. The City directs the Lancaster Port Authority to charge 5% seller fee to be retained by the Lancaster Port Authority with the remaining 95% of the sale going to the General Fund.

SECTION 5. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
