A RESOLUTION TO AMEND THE CERTIFICATE OF APPROPRIATIONS WITH THE COUNTY AUDITOR AND TO APPROPRIATE FROM THE UNENCUMBERED BALANCE IN THE CEMETERY FUND (207); LDOT FUND (208); LANCASTER PUBLIC TRANSIT FUND (221); GAS FUND (602); WATER FUND (603); WATER POLLUTION CONTROL FUND (604); SANITATION FUND (605); UTILITIES COLLECTION FUND (706); AND INFORMATION TECHNOLOGY FUND (720)
