A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO SUBMIT TO THE U. S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT LANCASTER'S FISCAL YEAR (FY) 2015 COMMUNITY DEVELOPMENT BLOCK GRANT ANNUAL ACTION PLAN AND STATEMENT OF OBJECTIVES

WHEREAS, the City of Lancaster will receive an entitlement allocation of \$454,698 in FY 2015 Community Development Block Grant (CDBG) funding; and;

WHEREAS, the city has prepared its FY 2015 Annual Action Plan to be consistent with the city's Consolidated Housing and Community Development Plan FY 2013 - FY 2017 which identifies housing and non-housing community development needs; and

WHEREAS, the FY 2015 Annual Action Plan has been developed in accordance with Lancaster's Citizen Participation Plan, including two public hearings conducted on March 30, 2015, and May 11, 2015, along with a publication of a summary of the proposed Annual Action Plan for public comment;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, OHIO

SECTION 1. The FY 2015 CDBG Annual Action Plan and Statement of Objectives/Use of Funds are hereby approved, as attached hereto and incorporated herein by reference.

SECTION 2. That the Mayor of the City of Lancaster is hereby designated as the official representative of the grantee and authorized to submit the Annual Action Plan and all certifications, assurances, and related documents to the U. S. Department of Housing and Urban Development (HUD), and to act in connection with the submission as may be necessary.

SECTION 3. That the Mayor of the City of Lancaster is hereby authorized to execute the FY 2015 CDBG Grant Agreement with the U. S. Department of Housing and Urban Development and to administer the Community Development Block Grant Program on behalf of the city.

SECTION 4. That this Resolution shall take effect and be in full force from and after the earliest period allowed by law.
