

TEMPORARY RESOLUTION NO. 121-15

PERMANENT RESOLUTION NO. 113-15

A RESOLUTION TO APPROPRIATE FROM THE UNENCUMBERED BALANCE IN THE GENERAL FUND (101), INCREASE RECEIPTS, APPROPRIATE FROM THE UNENCUMBERED BALANCE IN THE .45 POLICE & FIRE LEVY FUND (247), AND TO AMEND THE CERTIFICATE WITH THE COUNTY AUDITOR

WHEREAS, the Police Department paid into the General Fund One Thousand Three Hundred Sixty-Five Dollars (\$1,365.00) (reimbursement for cruiser rental); and

WHEREAS, the Police Department would like to appropriate the money that was paid into the General Fund into their vehicle supplies expense account in the .45 Police & Fire Levy Fund (247);

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, OHIO

SECTION 1. That the City of Lancaster Auditor amend the Certificate of Appropriations with the County Auditor in the amount of One Thousand Three Hundred Sixty-Five Dollars (\$1,365.00) in the General Fund (101).

SECTION 2. That the City of Lancaster Auditor appropriate from the unencumbered balance in the General Fund (101) into expense account 101.000.5907 (Transfer/.45% Voter Approved Levy) in the amount of One Thousand Three Hundred Sixty-Five Dollars (\$1,365.00).

SECTION 3. That the City of Lancaster Auditor increase receipts (estimated revenue) in the .45 Police & Fire Levy Fund (247) in revenue account 247.000.4986 (Transfers/General Fund) in the amount of One Thousand Three Hundred Sixty-Five Dollars (\$1,365.00).

SECTION 4. That the City of Lancaster Auditor appropriate from the unencumbered balance in the .45 Police & Fire Levy Fund (247) in expense account 247.325.5303 (Vehicle Supplies) in the amount of One Thousand Three Hundred Sixty-Five Dollars (\$1,365.00).

SECTION 5. That the City of Lancaster Auditor amend the Certificate of Other Sources and Appropriations with the County Auditor for the .45 Police & Fire Fund (247) in the amount of One Thousand Three Hundred Sixty-Five Dollars (\$1,365.00).

SECTION 8. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
