A RESOLUTION TO ACCEPT AND APPROPRIATE FUNDS FY 2016 CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT PROGRAM

WHEREAS, the City of Lancaster has received its FY 2016 Community Development Block Grant (CDBG) Grant Agreement and funding approval in the amount of Four Hundred Forty Thousand Seven Hundred Thirty-Five Dollars (\$440,735.00) for the program year commencing September 1, 2016, and

WHEREAS, it is necessary that said CDBG funds be accepted and appropriated in accordance with the approved and authorized FY 2016 program and program amendments;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, OHIO

SECTION 1. That the City of Lancaster's FY 2016 Community Development Block Grant in the amount of Four Hundred Forty Thousand Seven Hundred Thirty-Five Dollars (\$440,735.00) is hereby accepted..

That the above grant (\$440,735.00) and program amendments in the amount of Twenty-Nine Thousand Nine Hundred Forty-Five Dollars and Thirteen Cents (\$29,945.13) are appropriated as follows, in accordance with the FY 2016 CDBG Annual Action Plan as authorized by Council per Permanent Resolution No. 67-16.
