

TEMPORARY ORDINANCE NO. 23-17

PERMANENT ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE TO REPEAL AND REPLACE LANCASTER CODIFIED ORDINANCE PART ELEVEN – PLANNING AND ZONING CODE, CHAPTER 1101 – CITY PLANNING COMMISSION, SECTION 1101.02 – ORGANIZATION; TERM; NO COMPENSATION, OF THE CODIFIED ORDINANCES OF THE CITY OF LANCASTER, AND TO DECLARE AN EMERGENCY

WHEREAS, the City of Lancaster needs qualified individuals to serve on its Planning Commission and flexibility to permit another member of the Board of Park Commissioners to represent the Board at the Planning Commission;

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO:

SECTION 1. That Part Eleven – Planning & Zoning Code, Chapter 1101 – City Planning Commission, Section 1101.02 – Organization; Term; No Compensation shall be amended as follows:

**1101.02 ORGANIZATION; TERM; NO COMPENSATION.**

The City Planning Commission shall consist of seven (7) members as follows: the Mayor, the Safety-Service Director, the president of the Board of Park Commissioners of the City or his/her designee, and four (4) citizens of the Municipality who shall serve without compensation and who shall be appointed by the Mayor for terms of six (6) years, except that the term of two (2) members of the first Commission shall be for three (3) years.

SECTION 2. That existing Part Eleven – Planning & Zoning Code, Chapter 1101 – City Planning Commission, Section 1101.02 – Organization; Term; No Compensation, is repealed in its entirety.

SECTION 3. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, and for the further reason that this Ordinance is required to be immediately effective in order to promote the development of designated properties by allowing them to benefit from the fire capacity fee waiver.

SECTION 4. It is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all such deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
