

TEMPORARY ORDINANCE NO. 13-18

PERMANENT ORDINANCE NO. 16-18

AN ORDINANCE DETERMINING TO PROCEED WITH THE IMPROVEMENTS OF MAIN, COLUMBUS AND BROAD STREETS, BETWEEN CERTAIN TERMINI THROUGH THE DOWNTOWN SPECIAL IMPROVEMENT DISTRICT

WHEREAS, this Council has adopted Permanent Resolution Number 63-18 on July 16, 2018, declaring the necessity of making the improvements described in Section 1 pursuant to petitions received from the owners of at least 60% of the front footage abutting the proposed Lancaster Downtown Special Improvement District; and

WHEREAS, no objections to the special assessments or the SID renewal were presented by the statutory deadline;

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. It is determined to proceed with the improvement in the City on Main Street between Memorial Drive and High Street, Columbus Street between Wheeling Street and Walnut Street, and Broad Street between Wheeling Street and Walnut Street, though the Downtown Special Improvement District improvements consisting of maintenance, economic development, and other improvements.

SECTION 2. The improvements shall be made in accordance with the provisions of Permanent Resolution Number 63-18 and with the plans, specifications, profiles and estimate of cost previously approved and now on file in the office of the Clerk of Council.

SECTION 3. All claims for damages resulting from the improvements that have been legally filed shall be inquired into after completion of the improvements, and the Law Director is authorized and directed to institute legal proceedings in a court of competent jurisdiction to inquire into those claims.

SECTION 4. The portion of the cost of the improvements to be assessed in accordance with Permanent Resolution Number 63-18 shall be assessed in the manner and pursuant to the payment schedule set forth, and on the lots and lands described in that resolution.

SECTION 5. The estimated special assessments previously prepared and filed in the office of the Clerk of Council are adopted.

SECTION 6. The Clerk of Council shall deliver a certified copy of this ordinance to the County Auditor within 15 days after its passage.

SECTION 7. Subject to the provisions of Section 727.24 of the Revised Code, the Mayor is authorized and directed, as soon as the funds are available, to approve the improvements in accordance with applicable law, and the improvements shall be financed as provided in Permanent Resolution Number 63-18.

SECTION 8. This Council finds and determines that all formal actions of this Council and any of its committees concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, all in compliance with the law.

SECTION 9. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
