PERMANENT RESOLUTION NO. 4-19

A RESOLUTION TO APPROPRIATE FROM THE UNENCUMBERED BALANCE, AMEND THE CERTIFICATE WITH THE COUNTY AUDITOR IN LDOT IMPROVEMENT FUND (314), AND AUTHORIZE THE ISSUANCE OF A THEN AND NOW CERTIFICATE

WHEREAS, this legislation is to establish a beginning of the year revenue and expense budget for the LDOT Improvement Fund;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the City Auditor amend the Certificate of Appropriations with the County Auditor in the LDOT Improvement Fund (314) in the amount of Two Hundred Three Thousand, Four Hundred Thirty, and Nineteen Cents. (\$203,430.19).

SECTION 2. That the City Auditor appropriate from the January 1, 2019, unencumbered balances in the LDOT Improvement Fund (314) in the following expense accounts:
