A RESOLUTION TO ACCEPT AND APPROPRIATE FY 2021 FUNDS FOR THE CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the City of Lancaster has received its FY 2021 Community Development Block Grant (CDBG) Agreement and funding approval in the amount of Five Hundred Eleven Thousand Six Hundred Seven Dollars (\$511,607.00); and

WHEREAS, it is necessary that said CDBG funds be accepted and appropriated in accordance with the approved and authorized FY 2021 Program;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, OHIO

SECTION 1. That the City of Lancaster's FY 2021 Community Development Block Grant in the amount of Five Hundred Eleven Thousand Six Hundred Seven Dollars (\$511,607.00) is hereby accepted.
