A RESOLUTION TO APPROPRIATE FUNDS IN THE STORMWATER UTILITY RESERVE FUND (6019), AMEND THE CERTIFICATE OF OTHER SOURCES AND APPROPRIATIONS WITH THE COUNTY AUDITOR, INCREASE RECEIPTS, AND APPROVE THE ISSUANCE OF THEN AND NOW CERTIFICATE(S) FOR PURCHASE ORDERS PREVIOUSLY ENCUMBERED IN THE 6019 FUND AND NOW RE-APPROPRIATED IN THE 6019 FUND

WHEREAS, unspent balances within the Stormwater Utility Reserve Fund need to be reappropriated;
