A RESOLUTION OF CONSENT FOR THE FAI-37-19.61 OVERLAY EXISTING THREE SPAN SLAB, REPAIR PIER, MODIFY ABUTMENTS TO INTEGRAL DESIGN, PIER EASEMENTS, REPLACE APPROACH SLAB, DECK EDGE REPLACEMENT, TST RAIL, MINOR RESURFACING, USE ITEM 519 PATCH BOTTOM OF DECK, PART WIDTH CONSTRUCTION, THIS WORK WILL BE PERFORMED AS PART OF THE PID 91856, FAI SR 37 07.36/19.62

### **SECTION I - Project Description**

WHEREAS, the LPA has identified the need for the described project:

**Fai-37-19.62 – Overlay existing three span slab, Repair Pier, Modify Abutments to Integral Design, Pier Encasements, Replace Approach Slab, Deck Edge Replacement, TST Rail, Minor Resurfacing, use item 519 to patch bottom of deck, Part Width Construction. This work will be performed as part of PID 91856, FAI SR 37 07.36/19.62.**

WHEREAS, said portion of described project is within the Lancaster City Council area of responsibility.

NOW THEREFORE, be it ordained by the Lancaster City Council of Fairfield County, Ohio.

### **SECTION II - Consent Statement**

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

### **SECTION III - Cooperation Statement**

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

ODOT shall assume and bear 100% of the necessary costs of the State's highway improvement project. In the event that the LPA requests certain features or appurtenances be included within the State's highway improvement project's design and construction, and which features and appurtenances are determined by the State and FHWA to be not necessary for the State's project, the LPA shall contribute 100% of the cost of those items.

### **SECTION IV - Utilities and Right-of-Way Statement**

The LPA agrees that all right-of-way required (if applicable) for the described project will be acquired and/or made available in accordance with current State and Federal regulations. The LPA also understands that right-of-way costs include eligible utility costs.

The LPA agrees that all utility accommodations, relocations and reimbursements will comply with the current provisions of 23 CFR 65 and the ODOT Utilities Manual.

**Section V - Maintenance**

Upon completion of the Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the Project in accordance with all applicable state and federal law, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial provisions, as necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

**SECTION VI** This Resolution shall take effect and be in force from and after the earliest period allowed by law.

**SECTION VII - Authority to Sign**

The Service-Safety Director of said Lancaster City Council is hereby empowered on Michael J. Courtney, Service-Safety Director on behalf of the Lancaster City Council to enter into contracts with the Director of Transportation necessary to complete the above described project.
