## Instructions to The Applicant

The intent of the Easy Form is to speed up the zoning approval process required by City of Lancaster Ordinance Chapter 1155 for business owners who are moving into an existing business location without intending to alter, add to or change the zoning use. Applicants are to complete the application in its entirety providing the zoning inspector with all of the information requested. You may go to <a href="http://realestate.co.fairfield.oh.us">http://realestate.co.fairfield.oh.us</a> to find the correct information for item number 1. Use the "Quick Search" feature. A fee is associated with this application. Please refer to the Certified Building Department Fee Schedule found on the building departments web page located at <a href="https://www.ci.lancaster.oh.us">www.ci.lancaster.oh.us</a>.

A site plan of the property must accompany this application showing the business location and the parking provided for this space. The site plan cannot be smaller than 1-inch equals 50 feet in scale. A high quality aerial view of the property will be accepted in its place provided it shows all required detail.
